


# WARNING: PLEASE HANDLE WITH CARE! THE EDGES OF THE STAINLESS STEEL MESH & GRILLE CAN BE EXTREMELY SHARP!



 Open the hood and remove the two 10mm hex bolts retaining the hood release lever. Remove the lever from the bottom of the grille.



Apply masking tape to the chrome or painted surround on the factory grille. Remove the 10mm hex nuts from the top of the factory grille. Remove the grille from the hood.




**3**. Remove the factory phillips screws behind the center bar and around the emblem.




Carefully remove the factory center bar from the grille (not reused).




**5**. Carefully remove the emblem from the OEM grille by unclipping it.



 Locate and grind down the small raised portions on the factory grille (total of four, two each side). Grind carefully, the plastic push pins installed in the following step must cover the grinding marks.



8. Drill 1/4" holes where the small raised portions were removed and install the supplied black plastic push fasteners.




**9.** Make sure the chrome or painted surround is care fully taped and apply semi-gloss black paint to the factory grille (as shown).




 Clean the back of the emblem and install the supplied double faced tape to the back of the emblem (where shown, around the outer edges).




11. Peel off the double faced tape backing. Carefully align the emblem onto the emblem backing plate, making sure all the mounting studs pass through the slots in the mounting plate. Once properly aligned, press the emblem firmly in place to set the tape.



**12**. Once the factory emblem is installed onto the backing plate, turn the plate over and grind off the plastic alignment tabs flush with the back of the plate.






IMPORTANT: Trim the closed ends off the supplied  $1'' \times .156''$  vinyl caps and install one onto each mounting stud before assembling the grille (not shown).

- 13. Align the mesh and frame onto the factory grille, making sure that any protective masking tape that could get caught underneath the frame is removed first.
- 14. Install the black mounting plated over the protruding studs and install an ESNA half nut to secure. The bottom center stud will use a plastic washer and ESNA nut to secure. Once the frame and mesh are centered, tighten all mounting hardware.


15. Install the assembled emblem onto the grille, making sure the studs pass through the existing holes in the factory grille. You must trim the black plastic washers to clear the inside edge of the factory emblem opening before installing the stainless steel lock washers and hex nuts.




- **16**. Install the assembled grille back onto the hood, making sure you reinstall the hood latch bracket.
- **17**. Apply masking tape to the lower grille around the front tag mounting bosses (if equipped).




18. Use a small grinded to remove the plastic bosses. Grind them until they are flush with the grille fins along the sides and bottom, and across the top until you make contact with the J-clips securing the front bumper cover.




**19**. Paint the exposed J-clips black before installing the lower mesh grille.



**20**. Finish applying masking tape completely around the lower grille opening.



**21**. Install a 1" x .156" vinyl cap (trim off the closed end first) onto the lower mounting studs to conceal them once the grille is installed.



22. Align the lower mesh and frame into place. Install the supplied mounting bracket and ESNA lock nuts onto the mounting studs and begin tightening. Once the grille is snug but not completely tight, remove the protective masking tape from around the grille opening by pulling back over itself. You can move the grille around enough for clearance to remove the tape.



23. Finished installation.
