


 Open the hood and remove the outer phillips screws, center 10mm hex bolt and corresponding push fasteners to release the bumper cover from the support brackets.



For "S" and "Xrs" models: Pull the bumper cover out far enough to reach behind the factory grille and squeeze the emblem mounting clips and push the emblem straight out to remove.



 Trim and install the supplied .156" x 1" vinyl caps over the lower studs on the upper grille surround, making sure that several threads protrude from the vinyl caps (as shown). For Mesh Grilles: Align the mesh section onto the back of the upper grille surround.



4. Trim and install the supplied .156" x 1" vinyl caps over the lower studs on the lower grille surround, making sure that several threads protrude from the vinyl caps (as shown).




5. Use wide masking tape and carefully mask around the factory upper and lower grilles prior to E&G grille installation.




6. From underneath the vehicle, install the supplied black plastic washers and #8-32 ESNA half nuts onto each of the four (4) mounting studs and begin tightening.




7. Carefully remove the masking tape, peeling it back over itself to minimize tape breakage. You can shift the grille up and down and side to side for extra clearance when removing the tape. Once the tape is removed, finish tightening the lower hardware.



8. Carefully align the upper mesh section and surround (or "O" grille) into place, making sure the studs pass through the existing openings in the factory grille. Pull out on the bumper cover to access the back of the factory grille and install the supplied black plastic washers and #8-32 ESNA half nuts and begin tightening. Once you remove the protective tape, go back and finish tighening the ESNA half nuts.



10. For vehicles equipped with a front license plate bracket: Remove the factory license plate bracket lower mounting tabs from the bracket (see crosshatched areas), then reuse the factory upper mounting screws to reinstall.



11. For "S" & Xrs" Emblems: Grind off all mounting tabs with the exception of the cylindrical boss (see arrow). Reinstall the emblem onto the grille, passing the cylindrical boss through one of the mesh openings or "Q" slots and the factory grille opening and install it using the supplied washer and screw.



12. Finished installation.
